

May 20, 2013 VTXml Release Notes

This release has added additional functionality to the Distributor Configuration page and also the Tax Withholding page in support of AMP.

1) Distributor Configuration has added three new fields.


Under the Ownership Exclusions label two new fields have been added. Allow Exceptions To Min Premium and Allow Exceptions To Max Premium indicators will now allow a user to specify if a Distributor does or does not allow exceptions to premiums. These new fields exist at both the main level - which will apply to all Policy Products the Distributor sells - and at the Product specific level – for the exception products. The values specified will override the existing Policy Products values.



Additionally, a new section has been added called Authorization Exclusions which will allow a user to specify if a Distributor does not allow certain Authorizations.



For example if a Distributor does not allow Electronic Authorization then the user would check Electronic within the Business Method Exclusions checklist. If this action leaves the Authorization Business Method aggregate without any values in the output then the entire Authorization will be stripped.





2) Adding WithholdSameStateAsFederalInd to TaxWithholdingProduct

Under Tax Withholding Product, Are State and Federal the Same Withholding Type? is being added to support AMP processing. This will be passed as an extension – **WithholdSameStateAsFederalInd** - for Ebix 2.22 only as this new property is not even in the ACORD standard yet. Ebix will be writing an MR to submit for ACORD version 2.30. Carrier Facing Description is also being added to help differentiate between the other withholding rules. This field will be defaulted to *Please Update Carrier Facing Description*. Carriers should update this field to be useful. This will be passed as a comment in the xml and is used only as human readable text – not for processing.
